Established in 2017, KRN Heat Exchanger and Refrigeration Ltd is a leading manufacturer and exporter of fin and tube-type heat exchangers for the Heating, Ventilation, Air Conditioning, and Refrigeration (HVAC&R) industry. The company's product line includes condenser coils, evaporator units, copper header parts, fluid and steam coils, and sheet metal parts.

KRN specializes in the manufacture of copper and aluminium fin and tube heat exchangers, which cater to domestic, commercial, and industrial HVAC&R systems. Their range covers:

These products are designed to control air temperature, humidity, and purity in HVAC systems, serving OEMs and other clients globally.

KRN operates out of a consolidated manufacturing facility in Neemrana, Rajasthan, spread over 7,800 sq. mt. Their state-of-the-art plant houses advanced coil manufacturing machines, such as Hair Pin Benders, Fin Press Machines, CNC Tube Benders, and Vertical Expanders.

In addition, KRN exports 33% of its production to international markets, including UAE, USA, Italy, Saudi Arabia, Norway, Czech Republic, Germany, and the UK.

To further expand its product portfolio, KRN has incorporated a wholly owned subsidiary, KRN HVAC Products Pvt Ltd, focusing on manufacturing heat exchangers currently not produced by the parent company. This move supports forward integration and enhances their offering of value-added products.

However, the company is heavily reliant on Daikin Airconditioning India Pvt Ltd, which accounts for 33.34% of their FY 2024 revenue. The top 10 key customers contribute around 72.31% of the company's revenue for the same period.
